With reference to the D.O. letter No. NBCC:TTS:
BSM:LTR:95, dated the 17th July, 1995 from the
Chairman-cum-Managing Director, NBCC and in
continuation of this Ministry's sanction letter of
even number dated the 29th March, 1995 on the subject
mentioned above, I am directed to convey the sanction
of the President to the release of a grant of
Rs. 4,73,000/- (Rupees Four Lakhs and Seventy Three
Thousand only) to the National Buildings Construction
Corporation Ltd., New Delhi towards the
